About the Group



1st Fordingbridge Scout Group is a vibrant and friendly Group that offers a wide variety of adventurous and educational activities for boys and girls aged between six and eighteen.

All sections of Scouting are represented – Beavers, Cubs, Scouts and Explorers. Each of these sections is run by a team of qualified leaders who are ably assisted by a committee made up of parents and other supporters.

The Group was established in 1910 and since this time we have been an integral part of the local community. Today, we have over 80 young people involved in Scouting on a weekly basis.

As well as the regular weekly programme of activities, we offer our young people a wide variety of other organised events including trips out, camps, and, expeditions.

The Explorer Scouts also participate in the Duke of Edinburgh's Award Scheme – Their leaders are trained assessors for the expedition section of this award.

They also aim to take part in one international Scouting event each year and are actively planning a trip to Denmark in 2017.

Our Scout Group also holds a very popular family camp each year to which everyone involved in the Group is invited.

1st Fordingbridge Scouts involves itself in many local community events, including the Fordingbridge Festival during the summer and the Christmas Parade including the late night shopping event. We also run the local charity Christmas postal service as one of our many fundraising initiatives.

Our headquarters building is located in the heart of the town. In 2015, we began an ambitious programme of refurbishment and upgrading. We are very fortunate to have already received a number of grants from both local and national organisations, including the National Lottery. So far, this has enabled us to replace the aging asbestos roof dating back to the 1950's.

Further fundraising efforts to improve our facilities are ongoing.....

Due to our location on the edge of the New Forest National Park, the Scout Hall is very popular with visiting Scout Groups and Duke of Edinburgh Award expeditions. These groups use our facilities as a base for their adventures in the New Forest and surrounding countryside.

We also have a number of other local societies and organisations who regularly use our facilities.



New Roof October 2015



Removed existing asbestos roof, from the early 1950's, which was leaking, flaking, causing damage internally due to water ingress.

Replaced with modern roofing material, including additional insulation and with a more aesthetic look on the inside and outside.













Our plan to upgrade the HQ



ollowing on from the successful re-roofing of the building last year, the Scout group would like to refurbish the existing building to bring it up to a modern standard in terms of access and facilities for children of all abilities.

The current building was never designed with this brief and as such performs poorly in a number of key areas. To facilitate, the building requires alteration and modest extension. The majority of the re-organisation is internal however a small extension to the west elevation is proposed.

Access to the building



The building is currently accessed via a narrow ramped pathway. We are proposing to lessen the steepness of the ramp to improve access.

The current entrance is at the back of the building, this is a narrow single door which has a stepped threshold. We propose to relocate the main entrance at the front of the building providing a level access entrance door. The doorway will have a level landing area accessed by a compliant ramp and wide double door access with new glazed doors to improve visibility. The entrance will have a new canopy to provide weather protection to building users.

Disabled compliant circulation

Currently as you enter the building you are brought into a narrow long corridor straight into the hall. This is a claustrophobic area for all users and visitors and becomes severely congested when parents come to collect their children. Relocating the entrance to the front of the building provides the opportunity to create a generous lobby area which has a number of benefits:

- Improved access for disabled users allowing proper manoeuvring and operation of the entrance door.
- Improved circulation space for users allowing better access to other facilities and allowing free movement for able and assisted users of the building simultaneously.
- Provision of a separate waiting area for parents and carers at pick up and drop off times.
- Child Safety, separating the entrance and activity spaces allowing better safeguarding.



We also have to consider external circulation and access to outdoor activity spaces. At present this is again accessed by the narrow entrance door. This poses access and safeguarding issues as there is poor visibility between the two activity spaces. The proposal seeks to address this issue by directly connecting the hall and outdoor activity space through the current store area via a pair of glazed double doors. Again an access ramp is provided to the outside space. As the store building is constructed to a low specification it is proposed that this is re-built. This new side access provides better access to the storage area making loading and unloading of the Scouts camping equipment easier and safer, with alternative access points permitting activities in the hall to continue uninterrupted.

Disabled compliant facilities

The existing facilities are confined and out of date and do not meet the required standards for disabled users. The kitchen has been relocated and enlarged to permit better access and facilities for users which also improves safety by separating the kitchen from the hall with access via a hatch, to stop children entering the kitchen unsupervised. The larger kitchen permits supervised groups to participate in cooking activities, and better observation between the two spaces. To accommodate the relocated kitchen and office, which permits the relocation of the entrance, a single storey side extension is proposed.



Fundraising has already commenced and some funding has already been secured.

As this will be a fairly major overhaul of the building, it is proposed that the project be phased into two parts. This initial phase will be the replacement of the current store building and the upgrading of the toilet facilities. The following phase will be the kitchen and office extension plus the re-organisation of the hall to form the new lobby and entrance.

The overall objective of these works is to enable the Scout group to offer Scouting to children and young adults of all abilities in the Fordingbridge area.












Internal cutaway plan



Scouts raising roof in £35k campaign

THERE are exciting times ahead for 1st Fordingbridge Scouts after it raised £35,000 to complete the first phase of work to revamp its headquarters.

A special ceremony was held on Saturday to celebrate the completion of work to replace the ailing and leaky roof at Roundhill Hall.

The scouts raised money for the project themselves — holding a variety of fundraising activities including bag packing, raffles and quiz nights. Assistant scout leader Derrin Berry raised more than £2,500 when he took part in his first tandem skydive.

Grants and sponsorship were obtained from a number of organisations, which included £10,000 from the National Lottery Big Lottery Fund.

A donation of £600 from Ringwood and Fordingbridge Lions Club was given to the Scouts during the ceremony on Saturday.

1st Fordingbridge Scouts group chairman Martin Smethers said the project so far would not have been possible without the support of sponsors, parents, and scout leaders as well as the community.

He said: "We have got really ambitious plans for the future. We have got in the region of £7,000 left over from the initial appeal,

which is a good base to start our future work."

The next phase of the project will see the toilets and showers revamped and disabled facilities added to make the hall more userfriendly. The group hopes to carry out work both to the inside and outside of the building to smarten it up.

"It will enhance the facilities and make it much more accessible," added Martin.

Fundraising efforts will continue and the group hope work on the next phase of the project, which has been estimated at about £60,000, can start as soon as

Scouting exists to actively engage and support young people in their personal development, empowering them to make a positive contribution to society.

The Values of Scouting

As Scouts we are guided by these values:

Integrity We act with integrity; we are honest,

trustworthy and loyal.

Respect We have self-respect and respect for others.

Care We support others and take care of the world in

which we live.

Belief We explore our faiths, beliefs and attitudes.

Co-operation We make a positive difference; we co-operate with

others and make friends.

The Scout Method

Scouting takes place when young people, in partnership with adults, work together based on the values of Scouting and:

- enjoy what they are doing and have fun
- take part in activities indoors and outdoors
- learn by doing
- share in spiritual reflection
- take responsibility and make choices
- undertake new and challenging activities

Child Protection Policy



It is the policy of The Scout Association to safeguard the welfare of all members by protecting them from physical, sexual and emotional harm.

Accordingly The Scout Association is committed to:

- taking into account in all its considerations and activities the interests and well-being of young people
- respecting the rights, wishes and feelings of the young people with whom it is working
- taking all reasonable practicable steps to protect them from physical, sexual and emotional harm
- promoting the welfare of young people and their protection within a relationship of trust.

Code of Behaviour:

- **DO** put this code into practice at all times.
- **DO** treat everyone with dignity and respect.
- **DO** set an example you would wish others to follow.
- **DO** treat all young people equally show no favouritism.
- DO plan activities that involve more than one other person being present, or at least are within sight and hearing of others
- **DO** follow recommended adult/young people ratios for meetings and activities.
- **DO** respect a young person's right to personal privacy.
- **DO** avoid unacceptable situations within a relationship of trust e.g. a sexual relationship with a youth Member over the age of consent.
- DO have separate sleeping accommodation for young people, adults and Young Leaders working with a younger section.
- **DO** allow young people to talk about any concerns they may have.
- **DO** encourage others to challenge any attitudes or behaviours they do not like.
- DO avoid being drawn into inappropriate attention seeking behaviour e.g. tantrums and crushes.
- DO follow the Association's 'no alcohol' guidance when young people are in your care.
- DO make everyone aware of the Association's child protection procedures young people, parents/carers, Young Leaders and other helpers.
- DO remember this code even at sensitive moments e.g. when responding to bullying, bereavement or abuse.
- **DO** keep other Leaders informed of where you are and what you are doing.
- **DO** remember someone else might misinterpret your actions, no matter how well-intentioned.
- **DO** take any allegations or concerns of abuse seriously and refer immediately
- **DO NOT** trivialise abuse.
- **DO NOT** form a relationship with a young person that is an abuse of trust.
- **DO NOT** permit abusive peer activities e.g. initiation ceremonies, bullying.
- **DO NOT** drink alcohol when you are directly responsible for young people and never allow young people on Scouting activities to drink alcohol.
- **DO NOT** engage in inappropriate behaviour or contact physical, verbal, sexual.
- **DO NOT** play physical contact games with young people.
- **DO NOT** make suggestive remarks or threats to a young person, even in fun.
- **DO NOT** use inappropriate language writing, phoning, email or internet.
- **DO NOT** let allegations, suspicions, or concerns about abuse go unreported.
- **DO NOT** just rely on your good name to protect you.

If you have a concern about a young person's safety and well being:

- 1) Immediately tell your Group Scout Leader or District Commissioner
- 2) Write careful notes of what you witnessed, heard or was told
- 3) Sign, date and pass your notes to your District Commissioner
- 4) Ensure that no Scouting situation arises which could cause any further concern

If a young person tells you about abuse by someone else:

- 1) Allow the young person to speak without interruption, accepting what is said
- 2) Offer immediate understanding and reassurance, while passing no judgement
- 3) Advise that you will try to offer support but that you must pass the information
- 4) Immediately tell your Group Scout Leader or District Commissioner
- 5) Write careful notes of what was said; use actual words wherever possible
- 6) Sign, date and pass your notes to your District Commissioner

Ensure that no Scouting situation arises which could cause any further concern






